- (iv) **Management** of the organisation mentioning the dates of meetings of State Council, State Executive Committee, Planning Committee and other State level Committees.
- (v) **Infrastructure Development** - Training Centre, Headquarters Building developed or additions made etc.
- (vi) **Publication** - Journal published books released, Handouts, Information Bulletins published during the year 2015-16.
- (vii) **Finance** - Special Efforts for income generation other than Government Grant.
