SUB:- REGISTRATION FOR THE RASHTRAPATI SCOUTS & GUIDES/ ROVERS & RANGERS - 2016.....REG.

Dear Sir/ Madam,

New revised Application Forms for Rashtrapati Scout/ Guide/ Rover/ Ranger Award Badge are already uploaded in the Bharat Scouts & Guides website www.bsgindia.org and intimated the same to all the State Associations vide NHQ Circular No.67/2016 dated 31st May, 2016. No fee is to be paid for the Forms.

As per regular features, now registration for Rashtrapati Scouts & Guides/ Rovers & Rangers are invited from the eligible candidates who fulfill the requirements as given for Rashtrapati Scout/Guide/Rover/Ranger Award in APRO Part-II and III for respective Sections. All the Units will forward the applications to the District Headquarters and District Headquarters to State Headquarters. District and State Headquarters are also advised to check them before forwarding to the concerned Regional Headquarters to avoid disappointment i.e. rejections of the forms at the last moment.

This time we have tried our best to simplify the application forms supporting the spirit of Scouts & Guides, Rovers & Rangers and also provided the guidelines on how to fill the application forms which can also be accessed in our website www.bsgindia.org to curtail rejection of applications submitted to respective Regional Headquarters.

State Associations are requested to forward the Rashtrapati Scout & Guide, Rover & Ranger Applications to their respective Regional Headquarters as and when received in their State Headquarters without waiting for all the applications to be collected and sent in one lot. The Last date of receiving applications at Regional Headquarters is 31st July, 2016. Applications received after 31st July, 2016 will be considered for the next year. No extension will be given except in special cases.

While forwarding the applications, please read carefully and follow the instructions.

A. General Instructions:

1. Application forms for registration to the Rashtrapati Award Testing Camp will be accepted in the prescribed forms as uploaded in BS&G Website and in duplicate only i.e. 02 sets each of Registration/Application Form. To avoid rejection of forms, one may follow guidelines on how to fill the forms as endorsed vide NHQ Circular No. 67/2016 dated 31st May, 2016.

2. **Registration/Application forms are available in BS&G Website www.bsgindia.org. This can be downloaded and make use. No charges are applicable for the downloaded application forms. Hon'ble Chief National Commissioner is very kind enough to withdraw the charges fixed for downloaded application form.**
3. All Prospective Rashtrapati Award Testing Camps will be held at Regional Level. **No Testing Camp will be conducted in the building.** The prospective Rashtrapati Testing Camps will be held in open ground with camping under canvas at the well-established Training Centers only.
4. In the case of Scouts & Guides, Unit Leader must be minimum Advanced Trained and having valid Warrant whereas in the case of Rover & Ranger, Basic Rover/Ranger Leader having valid Warrant can recommend the application.
5. No Unit leader is eligible to recommend more than 25% of the members of his/her unit for the Award.
6. Date of Birth should be supported by a certificate issued by the Head of the Institution where the applicant is studying. In case the candidate has appeared for Board examination, photocopy of the Board certificate duly attested by the competent authority should be attached.
7. The Dates of completion of Pravesh, Pratham Sopan, Dwitiya Sopan, Tritiya Sopan and Rajya Puraskar should be as per the progressive advancement provided in APRO Part II /III for Scouts & Guides and Pravesh, Praveen, Nipun in case of Rover and Ranger. Candidates attending Prospective Rashtrapati Award Testing Camp should produce Progress Test Card maintained from the date of joining the Unit at the time of registration during the Testing camp
8. **The Date of completion of Rajyapuraskar/Nipun will be the last day of the testing camp conducted by the State** i. e. the date on which the state declares the candidate eligible for Rajya Puraskar/Nipun Award.
9. Tritiya Sopan Testing/ Praveen Testing Camp must be conducted at District Level, well in advance.
10. Rajya Puraskar / Nipun Testing Camp must be conducted at the State Level and qualified Scouts/Guides, Rovers/Rangers be awarded Rajya Puraskar/Nipun Award Certificate by the respective States.
11. Skills up to the Tritiya Sopan/Praveen, Rajya Puraskar and Nipun Test will also be tested in the Prospective Rashtrapati Award Testing Camps.
12. Rovers/ Rangers of the same unit must select different subject on "World Affairs" and submit a report to Crew / Team Council and its record with Log Book will have to be produced in the testing camp.
13. Please refer NHQ Circular No. 59/2016 dated 09th May, 2016. It is already informed that the Old Syllabus as per A.P.R.O. Part II & III will be considered for the transit period up to 2017-18 for the Rashtrapati Award. Candidates who have already opted

for the new syllabus need not hesitate; NHQ will consider both the cases in Scout Guide Spirit.


B. Proficiency Badges and Projects:

1. Proficiency Badges should be completed within the stage during which the Scout/ Guide/Rover/Ranger work for attaining the next higher stage. All Proficiency Badges must be tested by the Independent Badge Examiner appointed by the Badge Committee (District/ Local Association). It is the responsibility of the State Association to re-test the Proficiency Badges during Rajya Puraskar/Nipun State Level Testing Camp. (Unit Leader is not eligible to be the Independent Badge Examiner of the same Unit). Certificates of the Independent Badge Examiners should be countersigned by the concerned District Commissioners and to be produced by the candidate in the testing camp.
2. The Proficiency Badges of Rajya Puraskar/Nipun level is to be completed after qualifying Tiritiya Sopan/Praveen only. NHQ will re-test and will check the records of Proficiency Badges from Rajya Puraskar/Nipun onwards during the Rashtrapati Award Testing Camp
3. The requirements for Rashtrapati Award such as Camping, Ambulance/Ambulanceman Badge, Service Project, Hike and CD project, Badge Instructors / Teaching Games are to be completed after completion of Rajya Puraskar.
4. The duration of Project undertaken i.e. Hike, CD Project should be as per APRO Part II/III. The CD Project should be spread over at least in a period of six months same as in the case of Rovers & Rangers also.

Guidelines for Rashtrapati Award Testing Camp will be issued shortly.
