SUB.: HON'BLE PRIME MINISTER OF INDIA TO REVIEW PERFORMANCE OF YOUTH ORGANIZATIONS-REG.

Dear Sir/Madam,

It gives me an immense pleasure to inform you that Hon'ble Prime Minister of India had called a meeting of all the Youth Organizations of the Country on 18th April, 2016 at 06.30 P.M. in PMO's office to review schemes and activities of all the Youth Organizations.

Hon'ble Chief National Commissioner Shri B.I.Nagarale, I.A.S. (Retd) represented the Bharat Scouts & Guides in this high level meeting chaired by Hon'ble Prime Minister and actively participated in the deliberations and highlighted various Community development activities those are being implemented by the Bharat Scouts & Guides in the Country at all levels towards development and social change.

It is also to apprise you all that during the presentation made by the Secretary, Ministry of Youth Affairs & Sports, Govt. of India and all the Youth Organizations of the Country to Hon'ble Prime Minister, Bharat Scouts & Guides was specially mentioned and appreciated towards the role played under "**Swachh Bharat Abhiyan**" by the Scouts & Guides in the Country. This achievement is a proud moment to the entire 5.5 million Scouting/Guiding fraternity of the movement in the country.

During the cited Meeting, Hon'ble Prime Minister has appealed and directed that the following activities are to be undertaken by all the Youth Organizations at regular interval and submit its monthly report to the Ministry of Youth Affairs & Sports, Govt. of India with a copy to PMO by 10th of every month for further consolidation and to review the performance of all the Youth Organization.

1. **Swachhta efforts** by youth organizations should be more focused. The youth organizations should focus on taking up **cleaning of Schools/Colleges, Hospitals and Public Statues.**
2. Efforts should be taken to make certain villages in each District **Open Defecation Free by 12th January, 2017.**
3. A comprehensive Youth Portal should be developed, so that all information/data/applications of interested youth are available at one place.
4. All the youth organizations should proactively make use of Social Media to connect with youth.



5. **During May-June, 2016** all organizations should undertake measures to create awareness about **water conservation/recharge**. In light of district plans, concrete steps like building boribund, farm ponds, well recharge etc. should be taken and propogated.
6. **During July-August, 2016**, massive programme for **plantation** be taken up.
7. The youth organisation should also work actively to support implementation of the **"Indradhanush immunisation initiative"**.
8. During 2017, FIFA U-17 World Cup will be hosted by India. This may be looked at as an opportunity to popularise the game amongst youths in India and concerted efforts may be made.

In order to comply the above directives of Hon'ble Prime Minister, we most humbly appeal to all the State Associations to kindly motivate and encourage all the District/Local Associations in the State to take up these projects in their respective Units and submit a monthly consolidated report to the Bharat Scouts & Guides, National Headquarters, New Delhi **by 5th of every month in the Performa enclosed herewith** for further consolidation and submission to the **PMO** through Ministry of Youth Affairs & Sports, Govt. of India.



Our Hon'ble Chief National Commissioner is nominated as one of the members of this Coordination Committee to represent Bharat Scouts & Guides. This Committee will meet once in every month. **(Copy of the Minutes of Hon'ble PM's meeting and 1st Meeting of the National Coordination Committee of Youth Organization is enclosed herewith for your ready reference).**

Once again we request you to kindly expedite the matter as appealed above and submit the required report within the stipulated time in given performa so that National Headquarters will be able to submit its consolidated report of the country to the PMO on behalf of the Bharat Scouts & Guides in time.

We solicit your utmost cooperation in this great endeavor to bring Bharat Scouts & Guides in the top list in the activity report compared to other Youth organizations in the country as desired by Hon'ble Prime Minister.
