SUB.: UNIFORMITY IN RAJYA PURASKAR AWARD TESTING CAMP AT STATE LEVEL.

REF.: NHQ CIRCULAR NO. 43/2016 DATED 02.04.2016.

Dear Sir/Madam,

Your kind attention is invited towards NHQ Circular No. 43/2016 dated 02.04.2016.

To bring uniformity in conducting the Rajya Puraskar Award Testing Camp in the Organization, we have requested the State Associations to provide us the specimen copies of the Rajya Puraskar Testing Camp documents which are used in the States for further consolidation at the National Headquarters and to make these documents having uniformity. The last date to submit the specimen copies of the documents was earmarked as on 15.04.2016.

Till this date we have received the required documents from the following State Associations only.

(1) Andhra Pradesh, (2) Chhattisgarh, (3) Haryana, (4) Jammu & Kashmir, (5) Karnataka, (6) KVS, (7) Maharashtra, (8) Madhya Pradesh, (9) Mizoram, (10) Northern Railway, (11) Odisha, (12) Punjab, (13) Rajasthan, (14) Southern Railway, (15) Tamilnadu, (16) Telangana, (17) Uttarakhand and (18) West Bengal.

Similarly, to bring uniformity in Rajya Puraskar Award Certificates, we have also requested the State Associations to submit a specimen copy of the Certificates. Till this date only 04 States have responded and submitted the Certificates to NHQ i.e. (1) Haryana, (2) KVS, (3) Madhya Pradesh and (4) Rajasthan.



Hence, we would once again like to remind the States who have not submitted the **above documents and specimen copy of the Rajya Puraskar Award Certificate** to kindly submit the same to National Headquarters **latest by 10th July, 2016**. Failure to which it will be assumed that your State do not conduct Rajya Puraskar Award Testing Camp or Present Rajya Puraskar Award Certificates to the qualified Scouts & Guides for which NHQ should not be blamed, if Rashtrapati Award Applications of your State are rejected by the respective Regions while scrutiny of application due to absence of these documents with the State to prove authenticity.
