Greetings!

With reference to <u>WOSM Circular No. 46/2016</u>, "WOSM'S LEADERSHIP WORKSHOP, ASIA-PACIFIC REGION" and our email of 07 December 2016, we would like to encourage all National Scout Organizations in the Asia-Pacific Region to send participants to this important event which will be held from 24 – 26 February 2017 in Manila, Philippines.

The workshop aims at exploring three different tracks based on different applications of the Leadership in Scouting model, as described below:

Track 1: Youth Programme

It will focus on various existing and imaginative ways of implementing the model in the Youth Programme (e.g.: as a framework for a national Jamboree or as the basis for a leadership badge).

Track 2: Adults in Scouting

It will cover several different ways of using the Leadership in Scouting model applied to the management of adults (e.g.: NSOs' Scout leader training scheme; Wood Badge framework; or other adult training system).

Track 3: Organisational development

It will examine how the model can be useful for the organizational development of a troop, National Scout Organization (NSO) or Region (e.g.: committee election processes; change management; and other aspects of organisational development).

All of the three tracks will share a common start and wrap-up session. In between, you will focus on the track you selected to work on, by exploring and learning about leadership, together with other participants who share your specific area of interest and responsibility.

Participants: Adults who hold a role as trainers or/and in the leadership of an NSO. Participants are requested to arrive 23 February 2017 and may leave late in the afternoon of 26 February 2017, after the Closing Ceremony.

Working language: As the working language of the seminar is English, NSOs are requested to select participants who can communicate and actively take part in English.

Registration: USD150.00 per person which includes accommodation (from 23 February until 26 February 2017) and meals (Breakfast of 24 February until lunch of 26 February 2017). Please note that the workshop fee will only cover three nights and therefore, the workshop does not cover the night of 26 February 2017.
