### SUB.: NOMINATION OF MESSENGERS OF PEACE – STATE COORDINATORS.

Dear Sir/Madam,

The Bharat Scouts and Guides, National Association is recognized by World Scout Bureau as the leading NSO in the field of Messengers of Peace initiative since its introduction in the year 2011. However, it is felt that to consolidate the good work done by young people and to promote more efforts to post more projects in the world web [www.scout.org](http://www.scout.org) in a systematic manner State Level Coordinators ( honorary) are to be appointed.

The National Headquarters is inviting the proposals/nominations from state associations' suitable name of volunteers who can take-up the responsibility of promotion of the Messengers of Peace initiative in their respective states. The desirable qualifications for State Coordinators is :-

1. Preferably a graduate, Male or Female under 40 years.
2. Able to communicate in English/Hindi and Regional language orally and written form.
3. Ability to develop project proposals and prepare reports.
4. An active member of State Association.
5. Posses good relationship and communication skills.
6. Having scout/guide spirit.

They will be responsible for:-

1. To promote Messenger of Peace Initiative throughout the DA/LA and coordinate with state coordinator to develop the strategy for promotion and implementation of MoP.
2. Coordinate and communicate within the DA/LA and with SHQ in relation to MoP Initiative.
3. Support and strengthen the work of Messenger of Peace Network and monitor the platform in terms of registration of new members and projects.
4. Help in identifying need based areas in reference to MoP initiatives and developing MoP Projects to be funded under Mop Fund.
5. Coordinate the effective implementation of MoP projects and its reporting.
6. Participate in orientation and activities when invited
7. Keep him/ herself updated on the MoP initiative by studying the MoP Support Fund Booklet and through the MoP world and regional website.



The state associations are requested to recommend suitable names based on the performance of volunteers who are already involved in Community Development work and having skills to promote the Messengers of Peace initiative at Local, District and State Level under guidance of the state headquarters . The Names proposed by the state will be given preference. **However, if names are not received from states, National Headquarters reserve right to nominate suitable volunteers with intimation to the state.** The initial appointment of Coordinators will be for one year and renewable based on their performance.

The Warrant of Appointment of Coordinators will be issued under the signature of Honourable Chief National Commissioner and Director. The National Headquarters will arrange training of Coordinators before they are deployed. The successful completion of the training programme is a must for all coordinators.

The format for application is enclosed herewith for necessary action at your end.
