SUB: SUBMISSION OF NOMINATIONS FOR THE NATIONAL YOUTH COMMITTEE-REG. REF:NHQ CIRCULAR NO. 34/2017 DATED 30<sup>TH</sup> MARCH, 2017.

Dear Sir/Madam,

Your kind attention is drawn towards NHQ Circular No. 34/2017 dated 30.03.2017 on the cited subject.

The tenure of the previous National Youth Committee expired with the term of the National Council as on 26<sup>th</sup> November, 2016. The new National Youth Committee is to be constituted which will coterminous with the National Council 2016-21.

All the State Associations were requested to send the names of the members of the State Youth Committee to NHQ by 15<sup>th</sup>April, 2017in the proforma enclosed at Annexure-"A" and nominate one name for the National Youth Committee in the prescribed proforma enclosed at Annexure –"B" and submit the duly filled proforma along with brief bio-data of the nominee with email Id and contact No, Proof for Date for Birth duly recommended by the State Chief Commissioner for final selection to nominate for the National Youth Committee.

We regret to inform you that very few States have complied in the matter and submitted the list of State Youth Committee and nominated one name for the National Youth Committee as desired.

It is once again to "remind' you to please refer this office Circular No. 34/2017 dated 30.05.2017 and comply immediately. The list of State Youth Committee and one name for nomination to National Youth Committee should reach National Headquarters in the prescribed proforma latest by 30<sup>th</sup>May, 2017. The States who have already submitted the list may please ignore this circular.

If any State is not submitting the list of State Youth Committee within the revised stipulated date, it is the privilege of Chief National Commissioner to nominate any Youth Member from the State based on the eligibility and performance under the prescribed criteria if such Youth is found deserved. In such cases, the deserved name will be informed to the State Association for endorsement.

We solicit your affirmative response on the matter please.
