To strengthen the Movement and to provide opportunity to every District to have Assistant Leader Trainers / Leader Trainer, the Bharat Scouts & Guides, National Training Centre, Pachmarhi needed the Trainers details as per proforma enclosed, separate for Leader Trainers and Assistant Leader Trainers. Kindly advise the State Training Commissioner(S) to fill up the proforma to identify the District Association where Trainers are needed. Also a separate list of the District Association may be prepared of such Districts where do not have Trainers. This will help us to promote Scouting to unserved areas.
