

## SUB.: APR WORKSHOP ON YOUTH INVOLVEMENT.

We are glad to inform you that the APR Plan (2015-2018), adopted at the 25<sup>th</sup> APR Scout Conference in 2015, aims to support National Scout Organizations in implementing the World Scout Youth Involvement Policy. One of the action steps to achieve Objective No. 2, under the Youth People Strategic Priority, is to organize a regional workshop on Youth Involvement.

To achieve this strategic priority, the Asia-Pacific Regional Support Centre, in collaboration with Scouts Australia, is pleased to organize the APR Workshop on Youth Involvement in July 2018.

Name of Event	: APR Workshop on Youth Involvement
Dates	: <b>07<sup>th</sup> to 10<sup>th</sup> July, 2018</b> Four full days, inclusive of a half-day tour and not including arrival and departure. Participants should arrive 6 <sup>th</sup> July 2018 and may leave on 11 <sup>th</sup> July 2018. Please plan to arrive at Melbourne Tullamarine Airport (MEL).
Venue	: The venue will be <i>Pax Hill Activity Centre</i> in Ballarat, Victoria, north west of Melbourne. Pax Hill is a Scouts Australia camp site and adult training venue, and is about 90 minutes from Melbourne Airport.
Aim	: This workshop is aimed to gather key Scout leaders from National Scout Organization in the Asia-Pacific Region to look at how the World Scout Youth Involvement Policy is effectively implemented in National Scout Organization.
Provisional Objectives	<ul> <li>At the end of the workshop, the participants will be able to:</li> <li>Explain the World Scout Youth Involvement Policy</li> <li>Understand the importance of Youth Involvement in Scouting</li> <li>Analyse and consider the implications of this policy of their NSOs</li> <li>Meet with people with different expertise and share experiences on different aspects of Youth Involvement in Scouting.</li> </ul>

Eligible Participants	: Commissioners of any level in a NSO or full-time executives responsible or in charge of Youth Programme; and/or Unit Leaders who are actively serving as a Unit in their NSOs.
Working Language	: The working language of the Workshop is English. State Associations are requested to select participants who are able to understand and take an active part in discussions in English.
Workshop Fee	: The workshop fee is US\$ 150.00, which includes inland transportation between the international airport and the workshop venue, food and accommodation for five days and workshop documents/kit, and half-day educational tour etc.
