Agenda Item No.4:- Review of the WAGGGS & WOSM Adult Resource Policy.

The WAGGGS and WOSM Adult Resource Policies were circulated among the members and were duly presented in the power point. These were discussed at length in order to align with National Adult Resource Policy of the Bharat Scouts & Guides.

Agenda Item No.5:- Review the National Adult Resource Policy.

The existing policy was presented through power point presentation and the views of the members were invited. The members have discussed and finally agreed that the present steps of National Adult Resource Policy will be implemented. Shri M. M. Londe, District Chief Commissioner of Karnataka State Bharat Scouts & Guides has suggested that the Job Profile of District level to be prepared by Deputy Director(S), L.T. and Deputy Director(G), L.T. The house has also agreed that evaluation tools to be prepared and circulated to the States for getting feedback to be placed in Rules Committee.

The Committee has suggested that in the Rules Book National Adult Resource Policy Committee is not clear. The members are not specified. They suggests as follows.

At National Level:-

The Chairman will be nominated by National Commissioner. Director will be the Secretary. Joint Director(Scouts), Joint Director(Guides), Deputy Director(S), L. T., Deputy Director(G), L.T. will be the members. Other members will be nominated by National Commissioner.

At State Level:-

The State Chief Commissioner will nominate the Chairman. The members will be State Commissioner(S), State Commissioner (G), State Training Commissioner(S), State Training Commissioner(G), State Organising Commissioner(G) and not less than two Leader Trainers from Scout Wing and two Leader Trainers from Guide Wing. If the Leader Trainers are not available, then Assistant Leader Trainers may be nominated by the State Chief Commissioner. The State Secretary will be the Convenor of the State Level Adult Resource Management Committee.

At District Level:-

Chairman will be nominated by the District Chief Commissioner and the members will be District Commissioner(S), District Commissioner(G), District Training Commissioner(S), District Training Commissioner(G), District Organising Commissioner(G) and not less than two Leader Trainers from Scout Wing, two Leader Trainers from Guide Wing. If the Leader Trainers are not available, then Assistant Leader Trainers may be nominated by the District Chief Commissioner. The District Secretary will be the Convenor at the District Level Adult Resource Management Committee.
