<p><b>Agenda Item No. 1:- Confirmation of the Minutes of the last meeting held on 13<sup>th</sup> September, 2012.</b></p> <p>The minutes as recorded was duly accepted by the house unanimously.</p>	<p>No action is required.</p>
<p><b>Agenda Item No. 2:- Action Taken Report.</b></p> <p>Action Taken Report on the Minutes of the last Meeting of N. E. Region Development Sub-Committee which was already been circulated to the Members were unanimously accepted with regret that no action has been taken so far.</p> <p>Regarding the constitution of the above Sub-Committee, the Vice-Chairman Shri Khyomo Lotha felt aggrieved as it was not well represented by the members from the N. E. Regional States and it was not known to the N. E. State Associations before this meeting. The members present in the meeting expressed their satisfaction for constituting the present Sub-Committee with proper representation. of Strategic Plan, she will coordinate the States. She also stated that in the previous Strategic Plan we could not materialise some of the items. She suggested that this type of Strategic Workshop should be held region wise, state wise and also district wise which is duly accepted by the house. The Chairman expressed that this Agenda is not confined to N. E. States only but to all States.

As the Joint Director (SS) and the Incharge of Strategic Plan, all members are requested to get in touch with the State Associations and review it periodically.

**Agenda Item No. 4:- Development of N. E. Region.**

After a threadbare discussion for the development of N. E. Region ( State wise), the following points were unanimously accepted by the house:-

1. All the members of the Bharat Scouts & Guides of N. E. Regional States are facing much problem in attending the programmes and meetings held at National Headquarters and National Training Centre due to transportation difficulties and time consuming journey facilities. Hence all the members of the committee resolve that:-

The members representing any of the N. E. Regional States be allowed to avail the Air fare for their journey to attend the National Council Meeting and its Sub-Committees meeting.

The Officials and Trainers for attending any National/Regional Programmes, Meetings, etc, within any N. E. States be allowed to avail Air fare for journey, wherever it is available to minimise their journey problems and time.

2. All the State Associations of the Bharat Scouts & Guides of North East Region feel the necessity of shifting the office of the N. E. Region of Bharat Scouts & Guides from

2. Resolution was submitted to DONER Ministry, New Delhi on 28.06.2014. A copy of the same was submitted to former DONER Minister Gen. (Rtd.) V. K. Singh at Hotel Brahmaputra Ashoka,

the rented house at Azara to a new building within the Guwahati City, preferably in the State Headquarters Office premises of the Bharat Scouts & Guides, Assam at Panbazar, Guwahati which is nearest to the Guwahati Railway Station/ Bus Stand. All the members of Bharat Scouts & Guides from N. E. Region desire that the accommodation for the N. E. Regional Office be provided in the multi-storeyed building, proposed to be constructed by the Assam State Association in near future.

With the above idea and purpose in view, the N. E. Region Development Sub-Committee of the Bharat Scouts & Guides passed a resolution in the meeting to request the Hon'ble Minister DONER of India to kindly provide the fund for construction of the said multi-storeyed building for the interest of all the N. E. State Associations.

The Resolution is:-

" Resolved that the Hon'ble Minister DONER of India be requested to provide the necessary fund for construction of the multi-storeyed building for Scout Guide Organisation being proposed by the Govt. of Assam, wherein the N. E. Regional Office of the Bharat Scouts & Guides will be accommodated. "

3. It is resolved that all the N. E. State Associations are requested to move with the concerned State Governments for providing funds and other necessary facilities to upgrade their movement.

4. All the eligibility criteria for Unit leaders of the N. E. States for their progressive training, specially for weaker sections i. e. Cubs, Bulbuls, Rovers and Rangers may be relaxed or not to be counted for minimum of five years

Guwahati with a Plan and Estimate on 12<sup>th</sup> July, 2014 with State Chief Commissioner, BS&G, Assam & Chairman, N. E. Region Development Sub-Committee with other Office Bearers of BS&G, Assam State.

Mr. Arun Chandra Patar, Former Asstt. Director, NER along with Dr. H. C. Das, State Chief Commissioner, BSG, Assam State and Chairman of N. E. Region Development Sub Committee met former DONER Minister, Gen. (Retd.) V. K. Singh on 14<sup>th</sup> July 2014 and had a small meeting and a plan was submitted.

3. All State Secretaries of N. E. Regional States were requested over phone.

All the N. E. Regional State have been asked for the steps undertaken at the State Level. In the next meeting matter will be raised.

4. Minutes of the meeting submitted to NHQ.

5. HWB, Pre-ALT and ROT Courses should be conducted in any State of the N. E. Region but not in any State Training Centre outside the Region.

6. Regarding provision of land for Regional Training Centre, N. F. Railway Authorities be requested to provide a plot of land for Regional Training Centre at Amingaon, Guwahati and it is decided to meet the N. F. Railway Authorities by a Delegation from N. E. State Members.

7. It is resolved that the meeting of the N. E. Region Development Sub-Committee should be held two times in a year once at the National Headquarters and the other in any of the N. E. States to be decided by the Chairman.

8. It is resolved that all the State Associations of N. E. Region are requested to organise the Awareness programmes at different places of the concerned States about Scout/Guide Training of their children where the Guardians and Teachers along with the social leaders are to be invited.

**Agenda Item No. 5:- Increase in Census of N. E. Region.**

After a long discussion, it is resolved that all the State Associations of N. E. Regional States are requested to move with the concerned State Government to make the Scout Guide Training Compulsory for the students of all
