

At that time Hospital services like stretcher, blood donation/ blood grouping are very much required. National Service Scheme (NSS) Volunteers offer their services and Scouts/Guides/Rovers/Rangers should also give their services. How to use civic amenities at that time? First of all, we can tell people to use a dustbin and napkins, washing the hands before taking food, work to supply the required medicines under the guidance of medical experts, etc.
