Welcome Address and Introductory Remarks by the Chief National Commissioner.

Shri B. I. Nagarale, IAS(Retd.), Chief National Commissioner welcomed the Chairman, Office Bearers and members of the National Council. He appraised the house about the achievements of the Association and about Swachh Bharat Abhiyaan, Participation of the Bharat Scouts & Guides in WOSM and WAGGGS International Events, Messenger of Peace Initiatives and WAGGGS Initiatives such as Free Being Me, Surf Smart and Stop the Violence, etc.

At the outset, he took the opportunity to thank all the Hon'ble members of the National Council and Invitees to the Meeting of National Council. He expressed his deep sense of gratitude to each one of them for their whole hearted cooperation and guidance to the entire team at the National level which is trying its level best to take up and finalise the issues of prime importance and in the larger interest of the Movement. He also informed the august house about some of the achievements.

- Meeting of GSAT (Global Support Assessment Tool) -Third Party Assessment by WOSM held at the National Headquarters, New Delhi from 4th to 06th November, 2016. The Bharat Scouts & Guides has secured 75% marks in all the Assessment areas.
- 2. More stress was given to develop the computer designed badges with borders to bring them on par with the International standard and also to make them more attractive, etc.
- 3. The long awaited issue of amending the Rules, APRO Part-I, II, III and Scheme of Training (Scout Wing & Guide Wing) was taken in hand. Suggestions from all the stakeholders were invited and the Scrutiny Committee was appointed to examine the feasibility, necessity and suitability of the suggestions received. The Rules Committee and the National Executive Committee examined the proposed Rules and further recommended to the National Council which was held on 30th November, 2014. On the approval of this august house, all the six books were printed afresh. A care was taken to select the quality of paper both inner and the cover page. All the six books were brought out in Multi Colour. These books were made available on 14th April, 2015. It was for the first time in the history of the Bharat Scouts & Guides that a set of six books as referred to above was sent to all the members of the National Council, State Executives and the Professionals of the National Headquarters as complimentary sets.
- 4. He also apprised the Hon'ble members that the Bharat Scouts & Guides is the 2nd Country in Asia Pacific Region to revise their Boy/Girl Programme on par with the WOSM Policy after Indonesia. Our Multi Coloured Books were displayed in the Scout Mall during the recent 25th APR Scout Conference at Gwangju City, Korea which was highly lauded and appreciated by the top leaders of World Scouting.
- 5. The renovation and beautification of the National Headquarters building is under process which was a dream of all of us since long to see the National Headquarter building of an International standard. Till now about 70% work of the renovation is over and the rest will be completed very soon. The newly renovated building consists of offices of the Officers, a Conference Hall with all modern facilities having a seating capacity of 80 persons at the ground floor, independent double bedded rooms, dormitories for both the wings, a large

- size auditorium with enhanced sitting capacity, a spacious canteen, the Supply Service Department and other office rooms.
- Miss Meghana S. Belvadi from Karnataka has been elected as a Member of APR Guide Committee of WAGGGS in the APR/WAGGGS Conference held at Kathmandu, Nepal during September 2016.
- 7. The improvement of infrastructural facilities of NTC & NAI, Pachmarhi and NYC, Gadpuri have been finalised. MOUs in respect of all the above works have been signed and the work of NYC Gadpuri is in progress. The work of NTC & NAI has already been started.
- 8. Special attention has been given to N. E. Region for more number of events to be organised. States in N. E. Region are also being motivated for their participation in International events.
- 9. In response to the appeal by the Hon'ble Prime Minister of India, "Swachh Bharat Abhiyan" has been implemented in the Scout Guide Movement throughout the Country. Separate Monthly Bulletins on the issue have been printed and are sent to the Ministry of Drinking Water & Sanitation through the Nodal Ministry of Youth Affairs & Sports, Govt. of India.
- 10. Seven new zones of the Indian Railways have been recognised as States raising total number of Railway States to 16. A long pending demand of the Railway for more than a decade now stands complied with. A new Rule has been inserted to that effect.
- 11. New Rule has also been inserted for bifurcation of a Civil State.
- 12. The Chief National Commissioner along with National Headquarter Professionals met Hon'ble State Minister of Youth Affairs & Sports and the Secretary of Youth Affairs & Sports, Govt. of India and put before them the difficulties and discussed with them various issues relating the development of Scout Guide Movement. Our efforts to get the Govt. grants for the National Association fetched positive results. The Ministry of Youth Affairs & Sports released the Grant of Rs. 75 lakhs during 2015-16 as compared to the Grant of Rs.34 lakhs during 2014-15.
- 13. The Bharat Scouts & Guides was appreciated for achieving substantial growth in membership for the triennium 2012-2015, for organising three APR Events in India during 2012-2015, for significant contribution and support in promoting the Messenger of Peace. Nepal Scouts appreciated the generous contribution and assistance to them by Bharat Scouts & Guides in mobilising relief for rehabilitation of survivors after the major earthquake in April, 2015.
- 14. Projects of WAGGGS like Free Being Me, Stop the Violence, Surf Smart, etc. are being implemented very effectively.

He thanked again all the members of the National Council for their whole hearted cooperation for implementing and accomplishing the task taken in hand during last tenure.

After the welcome speech of Chief National Commissioner, the Chairman Shri K. P. Mishra brought the meeting in to order as per agenda items.

Agenda Item No. 1: Confirmation of the Minutes of the last National Council Meeting held on November 29, 2015.

The Minutes of the last National Council Meeting of the Bharat Scouts & Guides held on 29th November, 2015 were confirmed by the house as proposed by Smt. Sudesh Sharma, National Headquarter Commissioner (Bulbuls), Bharat Scouts & Guides and seconded by Shri P. Kalita, ASTC(S), Arunachal Pradesh State Bharat Scouts & Guides.

Agenda Item No.2: Business Arising (Action Taken Report).

The Action Taken Report was discussed at length.

Shri Vishnubhai D. Upadhyay, State Secretary, Gujarat State Bharat Scouts & Guides raised the issue of the Parallel Organisation namely Hindustan Scouts & Guides Association and enquired about the action taken by the National Headquarters of Bharat Scouts & Guides so far. He also informed that due to the activities of Hindustan Scouts & Guides Association, the Census of Gujarat State Bharat Scouts & Guides has decreased and the Govt. grant has been reduced. Hon'ble Chief National Commissioner informed the house about the initiatives taken to stop the activities of Hindustan Scouts & Guides Association. He also referred to the meeting with Shri Rajeev Gupta, IAS, Secretary, Ministry of Youth Affairs & Sports, Govt. of India and informed the progress to the house. The Representatives of Hindustan Scouts & Guides Association were also invited by the Ministry in the meeting referred to above.

The Chief National Commissioner informed the house that formalities for going to the Court of Law against the Govt. of India's Orders issued in September, 2013 re-recognising Hindustan Scouts & Guides are being completed. Legal advice has also been sought. Detailed representation has also been made to the Secretary, Ministry of Youth Affairs & Sports, Govt. of India, New Delhi requesting him to withdraw recognition granted by Govt. of India to Hindustan Scouts & Guides.

Shri L. M. Jain, Former National Commissioner, Bharat Scouts & Guides informed the house about their past efforts in this regard. He also asked the Chief National Commissioner as to why Court Case has not been filed so far against Hindustan Scouts & Guides. He raised question in regard to decrease of Govt. grants of the Bharat Scouts & Guides by the Ministry of Youth Affairs & Sports, Govt. of India.

Mr. L. M. Jain, IAS (Retd.), Former National Commissioner raised a question, how the funds accumulated in Corpus Fund have been spent on renovation of National Headquarters building and also on improvement of infrastructure at NTC/NAI, Pachmarhi and NYC, Gadpuri. He also raised a question as to how Corpus Fund has been spent.

Clarifying on the issue/question raised by Mr. L. M. Jain, the Chief National Commissioner explained that the National Headquarters building was in a dilapidated condition and renovation was badly needed. Renovation has, therefore, been rightly taken up. Moreover the work of renovation has been entrusted to NPCC (National Project Construction Corporation), a Govt. of India Enterprise.

Chief National Commissioner further pointed out and explained that the National Executive Committee in its meeting held in May, 2001 had resolved to the effect that the Corpus Fund can be spent only if the National Council resolves specifically. He continued to explain and said that the National Council resolved in its meeting held on 30th November, 2014 that Corpus Fund is allowed to be spent for the renovation work of National Headquarters building and for improvement of infrastructural facilities at NTC/NAI Pachmarhi and NYC Gadpuri.

It was at this point of time that Dr. S. K. Laha, SC(S), S. E. C. Railway stood up and said that the action of Chief National Commissioner in taking up the dilapidated building of National Headquarters for renovation is correct. He further said that the condition of the National Headquarters building could have gone from bad to worse, had the work of renovation not been taken.

Mr. Mahendra Kumar Singh, SC(S) of Uttar Pradesh State BS&G also strongly defended the action of Chief National Commissioner and said that how can one stay in a house without renovating it if it is constructed prior to independence i.e. 1947 and is in a dilapidated condition.

Adv. V. K. Narvekar, SC(S), Goa State strongly defended and appreciated the work of renovation of National Headquarters building taken up by the Chief National Commissioner with all due approvals of the competent Committees and National Council of Bharat Scouts & Guides. He appealed Hon'ble Shri L. M. Jain and the entire house not to raise any more questions on this issue as all procedural formalities have been followed by the Chief National Commissioner and the National Headquarters office.

Mr. Onkar Singh, SOC(S) of Punjab State BS&G pointed out that Chief National Commissioner has rightly utilised the money lying dead for renovating the National Headquarters building which was in such a bad shape. He further pointed out that huge amount is lying idle with Haryana State Bharat Scouts & Guides have not yet been utilised for Taradevi Training Centre which is badly required to be done.

Shri Sriniwas Kumar, State Secretary, Bihar State Bharat Scouts & Guides informed the house as to how Hindustan Scouts & Guides Association is trying to divide Scouting/Guiding in two parts in many States of the Country. He referred to the division of Scouting/Guiding by Hindustan Scouts & Guides in Delhi, Gujarat and Rajasthan etc. He also produced the approval of Govt. of Bihar while explaining this point.

Smt. Anamika Das, SOC(G), Odisha State Bharat Scouts & Guides requested the house not to wait for the action from National Headquarters to stop the activities of the Hindustan Scouts & Guides Association in the States . She appealed and said that the State itself should take necessary action in this matter.

Hon'ble Chief National Commissioner informed the house that Maharashtra State Bharat Scouts and Guides has faced same problems in the State. Shri Raj K.P. Sinha, a so called National Commissioner of a Parallel Organisation namely The Scouts/Guides Organisation has used the Govt. of India letter head in his correspondence. He further said that this issue was referred to the Ministry of Youth Affairs which later issued a clarification that 'The Scouts/Guides Organisation' is not recognised by the Ministry.

Dr. S. Kumar, Former Director, Bharat Scouts & Guides informed the house that the case of Hindustan Scouts & Guides Association was rightly pursued under the guidance of the then National Commissioner Shri L. M. Jain, IAS(Retd.). The case was personally attended by him as the Director of Bharat Scouts & Guides on the strict instructions from the then National

Commissioner. He also suggested that the National Headquarters should pursue the matter in the Hon'ble Delhi High Court.

Shri Khyomo Lotha, State Chief Commissioner of Nagaland State Bharat Scouts & Guides informed the house about the activities of Hindustan Scouts & Guides Association in Nagaland State and their approach with the State Govt. of Nagaland.

Shri Manoj Kumar Yadav, State Commissioner(S) of Jharkhand State Bharat Scouts & Guides requested the National Headquarters to take legal action and support from the Court of Law and the Media to stop the activities of Parallel Organisations such as Hindustan Scouts and Guides.

Some members suggested that a Delegation consisting of all the State Chief Commissioners of the Bharat Scouts & Guides should meet the Hon'ble Prime Minister of India in this regard. They also suggested to meet all the Governors in their States and also to take help from the Social Media.

The Action Taken Report was confirmed by the House as proposed by Smt. Sudesh Sharma, National Headquarters Commissioner(Bulbuls), Bharat Scouts & Guides and seconded by Shri Onkar Singh, SOC(S), Punjab State Bharat Scouts & Guides.

Agenda Item No.3: Consolidation and adoption of the Annual Report for 2015-2016.

The Director informed the house that the Annual Report was already sent to the National Council members by Post . The Annual Report for 2015-2016 was taken up for discussion. Dr. S. Kumar, Former Director, Bharat Scouts & Guides informed that the name of International Commissioner(S) of Bharat Scouts & Guides was not available in the report of International Events published in the Annual Report. Shri S. S. Kaushal, Hony. State Secretary of Haryana State Bharat Scouts & Guides expressed the concern over the decrease in census in some States though there is overall increase in the census. He also expressed that the facilities at grass-root level are to be increased for attracting more members and motivate them for movement to become as self-reliant and globally visible.

Shri Santosh Kumar Dixit of Uttar Pradesh State Bharat Scouts & Guides suggested that the Annual Report can cover with State wise reports along with photographs.



With the above cited suggestions and taking a note thereof by the National Headquarters, the Annual Report for the year 2015-2016 was adopted by the house as proposed by Smt. Kamlashini Tiwari, STC(G), N. E. Railway State Bharat Scouts & Guides and Seconded by Shri M. M. Londe, District Chief Commissioner, Karnataka State Bharat Scouts & Guides and Shri Ashok Chintaman More, National Headquarters Commissioner(Western Region), Bharat Scouts & Guides.

Agenda Item No. 4: Consideration and adoption of the Audited Statement of Accounts and Balance Sheet for the year 2015-2016.

The Audited Statement of Accounts and Balance Sheet for the year 2015-2016 as recommended by the National Executive Committee held on 23rd August, 2016 had already been circulated to all the members of the National Council.

Shri S. S. Kaushal, Hony. State Secretary, Haryana State BS&G enquired about the details of money spent towards renovation work of National Headquarters building, NYC, NTC & NAI of the Bharat Scouts & Guides.

Shri Vishnubhai D. Upadhyay, State Secretary of Gujarat State Bharat Scouts & Guides enquired about the unspent money of WAGGGS Projects and also about the 30% advance paid to NPCC.

Shri J. C. Mohanty, IAS, State Chief Commissioner of Rajasthan State Bharat Scouts & Guides enquired about the self certified running bills of NPCC Limited which was produced to National Headquarters for payment. The Chief National Commissioner explained the procedure of payment as contained in the MOUs.

Shri Gary James, SOC(S) of Meghalaya State Bharat Scouts & Guides has asked about the revised estimate and actual expenses against Sl. No. 21 i.e. International Events and Conferences. The Chief National Commissioner replied on this and explained that the event of the Conference of APR/WOSM was held in November, 2015 in the City of Gwanju, South Korea. Senior leaders were required to accompany the Chief National Commissioner as he was contesting election for the post of a Member, APR Scout Committee. Chief National Commissioner further informed that he was elected as the Member, APR Scout Committee which is certainly matter of great pride for Bharat Scouts & Guides.

The State Secretary of Gujarat State Bharat Scouts & Guides asked about the Retention money and its mobilisation. Hon'ble Chief National Commissioner informed the house in detail about the Retention money.

Hon'ble Chief National Commissioner explained the procedure of payment in detail by referring to the MOUs between the Bharat Scouts & Guides and National Project Construction Corporation Limited (NPCC), a Govt. of India Enterprise. He then appealed the house for approval of Revised Budget Estimate for the year 2016-2017 and Budget Estimate for the year 2017-2018.

Audited Statement of Accounts was adopted unanimously duly taking note of the suggestions of the Auditors for strengthening the accounting procedures.

The Audited Statement of Accounts and Balance Sheet for the year 2015-16 was adopted by the house unanimously.

The Revised Budget for the year 2016-2017 and Budget Estimates for the year 2017-2018 as recommended by the National Executive Committee held on 23rd August, 2016 were circulated to all the members of National Council.

The Chief National Commissioner informed the house that the National Headquarters submitted the detailed budget estimates to the Ministry of Youth Affairs & Sports, Govt. of India.

The Revised Budget for the year 2016-2017 and Budget Estimates for the year 2017-2018 were discussed and adopted by the house unanimously.

Agenda Item No. 6: Consideration of resolutions and subjects of which requisite Notice has been given and which are admitted by the President (See Rule 10(1)(c) of the Rules).

Rule 10, Subrule(1)(c): Notice of Resolutions duly proposed and seconded and subjects to the

consideration of the National Council shall reach the Director 30 days before the date of the meeting.

Director informed that no such resolutions have been received for discussion under this Agenda item.

Agenda Item No.7: Consideration of such matters as have been tabled by the National Executive Committee and included in the Agenda (See Rule 10(2)(g)).

Director informed that no such resolutions have been received for discussion under this Agenda item.

Agenda Item No.8: Consideration of such matters not included in the Agenda but which are brought before the National Council with the permission of the President(See Rule 10(2)(h) of the Rules).

There were no such resolutions received for being discussed under this Agenda item.

Agenda Item No.9: Consideration of the appointment of Auditors and fixing their remuneration.

The Chief National Commissioner informed the house that last time M/S Thakur & Company, Chartered Accountants, 221-223 D.D.U. Marg, New Delhi-110002 was appointed as Auditors on a remuneration of Rs.1,35,000/-per annum. Their performance is satisfactory.

Hence we may continue the same Auditors for the year 2016-2017 also. The house agreed with the proposal and the same was approved.

Agenda Item No.10: Any other matter with the permission of the Chair.

Shri P. G. R. Sindhia, State Chief Commissioner of Karnataka State Bharat Scouts & Guides who was permitted by the Chairman to speak, congratulated Shri B. I. Nagarale, IAS(Retd.), Chief National Commissioner, Bharat Scouts & Guides for the work he has done for renovation of National Headquarters building. He also praised Shri L. M. Jain, Former National Commissioner of the Bharat Scouts & Guides for his dedicated services to the Bharat Scouts & Guides during his tenure.

He informed about the progress in work of 17th National Jamboree of the Bharat Scouts and Guides to be held at Mysuru, Karnataka from 29th December, 2016 to 04th January, 2017. He also informed the house that an amount of Rs. 10 Crores has already been sanctioned by Govt. of Karnataka to conduct the Jamboree. First Information Bulletin and Second Information Bulletin

of the Jamboree have already been circulated. But Hindi version of Second Information Bulletin could not be prepared. He also requested the members to translate the Second Information Bulletin in Hindi. Karnataka State Bharat Scouts & Guides is also releasing a beautiful Souvenir in this regard. He requested all the Office Bearers and the State Chief Commissioners to send their message along with the photographs.

Shri M. A. Khalid, International Commissioner(S) of Bharat Scouts & Guides and State Commissioner(S) of Karnataka State BS&G explained the activities planned for 17th National Jamboree of the Bharat Scouts & Guides.

Shri Pritam Dutta, SOC(S) of East Central Railway State Bharat Scouts & Guides requested to decrease the registration fee of the Jamboree.

Shri G. Parameswar, SOC(S) of Telangana State Bharat Scouts & Guides asked about the pendency of P. M. Shield Award and Upa-Rashtrapati Award since last four years. The Chairman instructed the Director, Bharat Scouts & Guides to sort out the matter at the earliest.

Hon'ble Chief National Commissioner informed the house that WAGGGS has sent a proposal to the Bharat Scouts & Guides, National Headquarters to host the World Conference in India. He was also happy to announce that the Bharat Scouts & Guides will host the WAGGGS World Conference from 18th to 22nd of September, 2017 at New Delhi. About 700 lady participants as delegates and observers will attend and represent 146 Member Countries. He also informed that a green signal from the Ministry of Youth Affairs & Sports, Ministry of Home Affairs and Ministry of External Affairs, Govt. of India has been received to host the above cited Conference in India.

The Chief National Commissioner, however, requested the house to accord approval and resolve for hosting the WAGGGS World Conference.

Responding to the appeal of the Chief National Commissioner, the house unanimously resolved to host the World Conference of WAGGGS as the house thought it to be a great honour & pride for Bharat Scouts & Guides.

He informed the house about the Resolution on GSAT, Resolution for holding the World Conference of WAGGGS and Resolution on going to the Court of Law against Hindustan Scouts & Guides.

He also informed that the Rashtrapati Award Presentation Ceremony will be held on 05th December, 2016 at Rashtrapati Bhavan, New Delhi. He further informed that the Bharat Scouts and Guides Foundation Fellowship members are to be felicitated during the ensuing 17th National Jamboree scheduled to be held at Mysore, Karnataka.
