

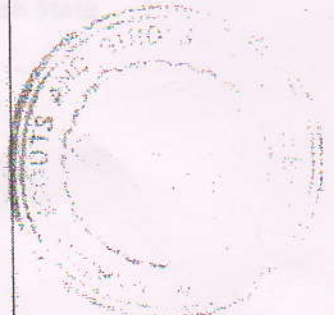



SUGGESTIONS TO BE INCLUDED IN THE TABLED TO BE DISCUSS ON SPECIAL NATIONAL COUNCIL - 09-07-2017

S. No	Present rule position	Suggestions
1	National Bye Laws 7.(viii) the Director who shall be the Returning Officer	The Director Bharat Scouts & Guides National Headquarters shall not be the Returning Officer for conduct of National Council Elections. Returning Officer shall be nominated by the President of the National Association for more transparency
2	State Bye Laws The State Secretary who is the Returning Officer	At State Level also the State Secretary should not be the Returning Officer to conduct Elections to the State Council. A nominated person appointed by the President of the State Association shall be the Returning Officer to conduct Elections
3	Rule No 6 of the Rules (National Council Members)	The Professionals (Employees) who are working at National Headquarters/ NTC/ or at any place should not be the electoral members to exercise their franchise during National Council or any other Elections to ensure free and fair conduct of Elections
4	Rule No 45 of the Rules (State Council Members)	The Professionals appointed by the State Chief Commissioner working at State Headquarters /District Headquarters not permitted to participate and cast their vote. in the Elections
5	Rule No 6 (National Council)	Include Life members representatives at least FIVE Elected from among themselves (as practice for State Council Rule No 45 (24)
6	Rule No 43 (d)	Categories of the membership 43 (d) Members of the District or Division / and Local Association shall not be participated in Elections NOT CLEAR
